CONDITIONS

- 1) The selected candidates shall produce physical fitness certificate obtained from the Civil Surgeon or District Medical Officer as per annexure to Rule 6(12) of the above Rules.
- 2) The selected candidates shall furnish an undertaking that he/she does not and will not have any such financial or other interest as is likely to affect prejudicially his/her functions as a President or Member, as required under Rule 6(13) of the above Rules.
- 3) The State Government will verify the credentials and antecedents of the recommended candidates as required under Rule 6(11) of the above Rules.
- 4) The selected candidates shall declare his/her assets, and his/her liabilities and financial and other interest as per the Consumer Protection (Salary, Allowances and Conditions of Service of President and Members of the State Commission and District Commission) Model Rules 2020.
- 5) The candidates shall submit the required documents as at Sl.No.1, 2 and 4 within 07 working days from the date of publication of the selection list.

- 6) The place of posting shall be indicated after counseling of the selected candidates on the basis of merit and after examining the documents submitted by the candidates, the appointment order will be issued.
